PLANNING TO SELL?

Dear Home owner,

As the owner of a property, you, as the Seller, are required in terms of the Municipal Building Regulations to apply for a Building Compliance Certificate in order to sell your property.

How do I apply?

You, as owner, or your estate agent or property laywer, may apply at the Building Control Division of the City of Windhoek.

The cost?

You must pay N575.00 in favour of the City of Windhoek and you will need the correct ERF number.

What next?

After your application, an inspector of the City of Windhoek will call you, as owner, in order to arrange an inspection of your property.

The inspector will establish whether there are approved building plans and whether the approved plans are in accordance with the structures on the property.

What if the inspection fails?

If the structures are NOT in accordance with the plans, you will need to instruct a competent draftsperson to draw and submit new plans for approval to the City of Windhoek.

The approval of these plans may take up to 3 to 6 months, but the City of Windhoek has provided an Agreement which allows the Municipality to issue an Interim Compliance until your plans are approved. This agreement will have to be signed by the Seller, Purchaser and Municipality, and shifts the responsibility of the plans to the Purchaser.

The Municipal agreement does not make provision for the following and this will have to be attended to before transfer of your property:

- · Firewalls that need to be built
- Plastering and painting of neighbouring walls
- Swimming pool covers
- Gates that are on the pavement
- Shacks or illegal structures on the erf
- A self-closing fire door in the garage
- Any roof vents that need to be installed

IT IS OF UTMOST IMPORTANCE THAT YOU AS OWNER APPLY AS SOON AS POSSIBLE TO AVOID ANY TIME DELAYS OF YOUR TRANSACTION.

Further TIPS to make your home special:

Kitchens & Bathrooms can make or break a sale:

- Clean all appliances, fittings, sanitaryware and shower doors
- Invest in a new shower curtain
- Pack away clutter from your countertops
- Banish dirty washing to the laundry bin

The exterior:

- Ensure the front door is clean, the handles & locks
